Digital Space (the "Company"), a leading Secure, Connected Cloud MSP, today announced that it is to be acquired by Graphite Capital ('Graphite') from Horizon Capital ('Horizon'), which has owned the Company since February 2017. The transaction, the terms of which were not disclosed, is subject to regulatory approval.

Digital Space provides connectivity, security and hybrid cloud managed services to the UK mid-enterprise and public sector markets. It delivers its comprehensive services from its own datacentres, national core network and Network Operations Centre, along with its public cloud-based services and solutions.

Graphite, a leading UK mid-market private equity firm, was attracted by Digital Space's well-invested and modern services platform, its strong customer base, and the experience of the leadership team. Digital Space is well positioned to meet the growing demand for digital transformation solutions and ICT managed services, as companies leverage modern technologies to drive operational efficiency and customer experience.

Following completion of the acquisition, Neil Muller and his management team will continue to lead the business, with a strong focus on organic growth (through ever-increasing demand for high-speed, low-latency network connectivity; hybrid cloud transformation; workforce modernisation; improved end-user experiences; and security services), augmented by strategic acquisitions, to meet customers' ongoing digital transformation and managed service requirements.

Headquartered in Newark-on-Trent, Nottinghamshire, Digital Space employs 340 team members. Digital Space was originally founded (as Timico) in 2004, with CEO Neil Muller appointed in November 2018. Following a series of strategic acquisitions, the company rebranded as Digital Space in 2021.

The fund has also invested in NRS Healthcare, a provider of community products and services that help the elderly and disabled live independently in their own homes; Horizon Care and Education, a provider of high-quality care and education for young people with social, mental and emotional needs; and Hanson Wade, a global leader in data and information services to R&D life sciences.

The most recent realised investments include YSC, the leadership strategy consulting services provider; Random42, the world's leading independent producer of scientific animation and digital media services; U-POL, the manufacturer and distributor of automotive repair and refinishing products; and City & County Healthcare Group, the UK's largest domiciliary care provider.
